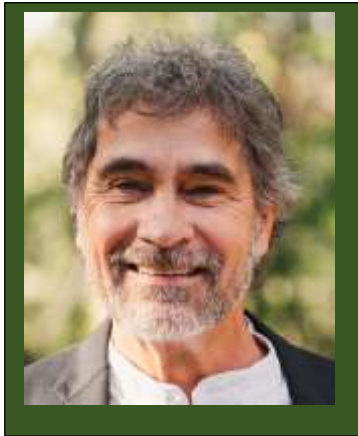

Those are real savings for building owners and occupants and the reduced energy use from such improvements as more efficient windows or thicker insulation also helps avoid the pollution from fossil fuel-fired electricity generation that fuels climate change.”
