GOE Grant Supports Rural Nevada Solar Water Heating Program

Carson City, NV (January 17, 2014) – More residents of rural Nevada are saying good-bye to costly propane tanks and hello to more efficient solar water heaters thanks to a \$5,000 grant the Governor's Office of Energy (GOE) awarded to Valley Electric Association, Inc. (VEA).

The grant allows VEA, a member-owned electric cooperative based in Pahrump, to fund propane-to-solar

conversions for 10 to 12 homes in the cooperative's service territory in southwestern Nevada.

"This grant fits in perfectly with GOE's mission to collaborate with local partners and ensure a reliable and sustainable clean energy system," said Paul Thomsen, GOE Director. "Taking households off propane and moving them onto solar water will conserve or reduce the demand for energy resulting in energy efficiencies which are required by NRS 701.180"

The cooperative has installed more than

installing a solar water heating system from Valley Electric Association. 800 solar water heating systems since 2009, when it launched its domestic solar water heating program. GOE recognized the merits of the program by awarding VEA a \$5,000 grant in the fall of 2012, and then again last year.

"We would like to thank the Nevada Governor's Office of Energy for its continued support of our domestic solar water heating program," said Tom Husted, CEO of Valley Electric Association, Inc. "This valuable grant will provide a number of local families with opportunities to reduce their power bills by switching to high-quality solar water heating systems."

The decision to award consecutive grants to VEA highlights GOE's ability to facilitate cooperation among stakeholders, lead initiatives to stimulate economic development, and attract energy related business ventures that include site development, generation and production, and inter/intrastate transmission.
