NOTICE OF WORKSHOP TO SOLICIT COMMENTS ON PROPOSED REGULATION

The Governor's Office of Energy (GOE) is proposing the amendment of regulations pertaining to Chapter 701A of the Nevada Administrative Code (NAC). A workshop has been set for 3:30 p.m., on November 19, 2018, at the Grant Sawyer Building 555 E Washington Ave #5100, Las Vegas, NV 89101 and via videoconference at the Governor's Office of Energy 755 N. Roop Street, Suite 202, Carson City, NV 89701. The purpose of the workshop is to solicit comments from interested persons on the following general topics that may be addressed in the proposed regulations:

Revising provisions governing the partial abatement of certain property taxes for buildings and structures which meet certain energy efficiency standards; and providing other matters properly relating thereto.
