FISCAL IMPACT Renewable Energy Partial Abatement of Sales/Use Taxes July 24, 2024

Sierra Solar Phase 1 Project

In accordance with the provisions NRS 701A of the Nevada Revised Statutes, Sierra Solar Phase 1 Project has requested a Sales and Use Tax Abatement for their Renewable Energy Project. This project is located in Churchill County. Upon approval, this project would be granted a partial abatement of Sales and Use Tax for a period of three years, commencing on the date of approval.

The Governor's Office of Energy has provided to the Department of Taxation a completed copy of the Renewable Energy Tax Abatements Application for this project. According to Schedule 6 of this application, Sierra Solar Phase 1 Project will purchase a total of \$658,391,915.00 worth of tangible, personal property subject to Sales and/or Use Tax during the first year of the abatement period. At the current Sales or Use Tax rate for Clark County, the full Sales Tax for these purchases would be \$50,037,785.54 less any applicable collection allowance.

According to Schedule 7 of this application form, Sierra Solar Phase 1 Project will purchase \$252,658,942.00 worth of tangible, personal property subject to Sales and/or Use Tax during the second year of the abatement period. Schedule 8 shows \$0.00 of tangible, personal property subject to Sales/and or Use Tax will be purchased during the third year.

Based on this information, the Department of Taxation projects the following Sales Tax related fiscal impact for the three years of the abatement period.
