### **1. Call to Order and Opening Remarks:**

The meeting was called to order at 11:00 AM by Robin Yochum, Energy Program Manager. Mrs. Yochum thanked everyone for attending the workshop and provided regrets from Director Bobzien that he could not attend the meeting. Mrs. Yochum introduced Deputy Director Jennifer Taylor.

Deputy Director Taylor thanked everyone for attending the workshop. Mrs. Yochum identified that these meetings are not being conducted pursuant to NRS 233B as there are no regulations being amended. Mrs. Yochum also reminded participants that this is being done to allow stakeholders the opportunity to comment on the adoption of the 2021 IECC and that the appendices are being added as a guide for local governments and not intended to be mandatory.

### **2. Public comment:**

Mr. Hodgson, Mr. Fernandez, Mr. Frommer and Ms. Derrickson provided verbal comment, and comments were largely supportive.

### **3. Appendices drafted for Discussion**

Mrs. Yochum shared her screen and reviewed the proposed amended language for Section C108 reference standards. Mrs. Yochum, Mr. McOsker and Mr. Meyers discussed the proposed amendments submitted by Mr. Krahenbuhl and identified that this would need to be addressed outside of the workshop, as GOE did not intend to amend the base code as published.

Mr. McOsker asked to have the appendices reformatted for clarity as the way they are currently formatted indicates amended language. Ms. Yochum agreed and asked Mr. Meyers to assist her with the reformatting prior to the next meeting.

Mrs. Yochum asked if there were any more comments and reminded attendees of the upcoming hearing on July 28, 2021, mentioning it would not be a typical hearing in accordance with NRS 233B because no regulations are being amended, but a notice of the adoption of the published 2021 IECC codes.
